# SPOTLIGHT ON HUMAN RESOURCE MANAGEMENT

The Society for Human Resource Management (SHRM) awarded a 2015-2016 Outstanding Student Chapter Award designation to the Athens State University SHRM student chapter for providing superior growth and development opportunities to its student chapter members. This is a repeat performance for the student group as they earned outstanding recognition in 2015 and 2014, and superior is 2013. Two hundred six schools from across the United States applied for the award and Athens State University was one of 163 winners.

The SHRM student chapter merit award program, which began in 1972, was created to encourage student chapters to require ongoing excellence in the following areas: student chapter requirements, chapter operations, chapter programming and professional development of members, support of the human resource profession, and SHRM engagement.

"These chapters truly represent the future of the HR profession," said Susan Post, SHRM-SCP, East Divisional Director at SHRM and the lead for SHRM's Student Programs. "Their achievements go above and beyond their everyday academic and work commitments and we applaud the positive impact their efforts have on their schools, their local communities and beyond."

SHRM student chapters had the opportunity to earn an award based on the number of activities they completed during the merit award cycle, which lasted from April 1, 2015, to March 31, 2016.

### **Quality Matters**

Quality Matters is a nationally recognized, faculty-centered, peer review process designed to certify the quality of online courses and online components. The Quality Matters Rubric has become one of the most widely used sets of standards for the design of high quality online and blended courses at the college level. Today, more than 850 colleges and universities subscribe to Quality Matters. The QM Process focuses on quality assurance efforts in online learning and assists faculty with making the transition into distance education.

Athens State University's College of Business recently submitted is Operations Manage-

ment course (MG 390), developed by Dr. Kim Roberts and Dr. Mark Gale, to be reviewed by a team from Quality Matters. In order to meet Quality



Matters review expectations using the Fifth Edition of the Quality Matters Rubric, a course must meet 21 essential standards. In addition, the course must receive a mini-

mum of 84 (out of 99) points among all 43 standards.

The University is pleased to report that the course met each of the 21 essential standards and received 99 out of 99 possible points. The course is now eligible to carry the QM Certification Mark.

"While this process involved a significant time commitment, I found it to be well worth it," states Roberts. "In addition to receiving course certification, we gained valuable feedback and recommendations from the external reviewers to make the course even stronger for our students."

# ATHENS STATE UNIVERSITY GRADUATE SALARIES AMONG THE HIGHEST IN STATE

According to the U.S. Department of Education, Athens State University is ranked number one for its return on investment for any college of its size in Alabama. According to the Department's College Scoreboard, Athens State graduates earn an average of \$39,700 annually at 10 years after attending the school. This salary amount places Athens State at the top of the list among Alabama small public colleges with student populations under 5,000.

"What is impressive about our graduates' compensation levels is the fact that they are \$5,000 over the national average of earnings at

the 10 year mark," states Athens State University President Bob Glenn. "It is well known that Athens State has the lowest tuition



rate in the state, but with the release of these salary figures, it is clearly evident that we are producing well-educated and career-ready graduates who are excelling. I attribute this to an exceptional faculty and innovative delivery methods."

Of the 28 total baccalaureate institutions in the state, Athens State was ranked eighth overall for its graduates' return on investment. This category pitted Athens State against some of the largest institutions in Alabama, both public and private.

The Athens State University chapter of the Institute of Management Accountants (IMA) received three top national awards at the IMA Student Leadership Conference in Orlando, FL last December. It was one of only three student chapters across the country to receive the Outstanding Student Chapter Award and the only chapter to receive Best Communications Award. The club was also honored with the IMA Gold Award of Excellence.

"These awards were the result of countless hours of work over the last year by a group of exceptional students that we are very proud to have at Athens State," said Professor Stacie Hughes, Chair for the Accounting Department.

The Accounting Club members completed community service projects throughout the year to benefit eight charitable organizations. They organized and attended four industry tours, twelve educational meetings with guest speakers, four career development workshops, and thirteen social events designed to promote the Accounting Club and the University.

Students of the club earned over \$13,500 in scholarships from the IMA and one student was awarded an all-expenses-paid trip to Dallas to attend meetings with the IMA's Global Board of Directors.

## **Athens State's Economic Impact**

In August 2016, Athens State University released an economic impact study that shows the institution generates about \$89.18 million dollars and 503 jobs each year for the local economy. The authors, Dr. Bill Wilkes, Professor of Economics, and Cary Payne, Adjunct Professor in Health Care Management, believe this report draws attention to the University's initiatives and highlights its positive economic and non-

economic impact on north Alabama.

"Athens State has an enormous impact on the area communities in northern Alabama," states University President Bob Glenn. "The academic and professional expertise of our faculty supported by an excellent staff makes the Uni- Sanders Hall, College of Business Home

versity not only a great academic institution, but highlights our University as an engine for business and industry development."

Using a conservative financial multiplier of 2.0115, the report authors surmised that an annual return on investment to the local economy by Athens State University is \$8.62 for every revenue dollar received. The dollar figure does not include non-
