New Minors and Certificates Approved

The College of Business is pleased to announce the addition of two new minors and two new certificates for the 2017-2018 academic year.

Accounting Minor: Where money is involved, so is accounting. This minor is intended to provide a solid foundation of the essential accounting concepts that can contribute to financial success, both personally and professionally. The minor requires students to choose an elective, which will allow them to get specialty knowledge in an area that would be most beneficial to their chosen field. The minor is open to nonaccounting majors.

Forensic Accounting Mi-

nor: The field of accounting is growing at a steady rate, and it is forecasted that forensic accountants will be in even higher demand than other accounting careers. This is due to the increase in both white collar crimes and the regulations put in place to prevent those crimes. The minor would serve to prepare students for the major professional certifications in forensics: Certified in Financial Forensics (CFF), Certified Fraud Examiner (CFE), and Forensic Certified Public Accountant (FCPA).

Accounting Certificate: This certificate would give individuals who do not wish to complete a full academic program the ability to complete a finite program in accounting. This would include students who attend Athens State in order to fulfill hours requirements for government and government-related jobs.

Human Resource Management Certificate: This certificate contains 15 semester hours of human resource management coursework that can enhance the current HR professional or provide a working knowledge of the HR field. A person who is a current HR professional or has at least one year of experience in HR, can petition to have the beginning HR course waived in exchange for a second elective HR course that will best meet his or her specific career objectives.

A Unique Opportunity for Graduate Credit

The College of Business is pleased to tell you about a unique opportunity that has been made available to students with a major in either Acquisition and Contract Management or Logistics and Supply Chain Management. In these two majors, there is an area for six hours of specific electives. students can take the first two graduate-level courses in our Global Lo-




gistics and Supply Chain Management program (LSM 600 and LSM 601) to satisfy these undergraduate elective hours. Then, should you be accepted into the Master's program at Athens State University, you will have only eight more graduate courses remaining to earn your Master's. If earning a Master's is part of your approved educational plan, this could save you both time and money. Individual students should consult with Financial Aid regarding whether or not their financial aid plan will pay for the graduate courses.

College of Business Holds First Graduate Commencement

Congratulations to the six students in the first cohort who graduated from the Global Logistics and Supply Chain Management Graduate Degree Program. The students are David Currier. Garrett Ennis. Valerie Holmes. Melissa Kaiser, Zachariah Lowery, and Christopher The Commencement Moss. ceremony was held on Saturday, December 9, 2017, at 12:00 p.m. on the campus of Athens State University.

There are currently 15 students in the second cohort for the graduate program. These students are expected to graduate in Spring, 2018. There are currently 35 students enrolled in the third cohort and applications are being accept-



ed until July 15 for the fourth cohort.

Athens State University received approval from the Alabama Commission on Higher Education (ACHE) to begin offering a Master's of Science in Global Logistics and Supply Chain Management in December 2014. This was followed by a SACS level change approval in 2015. The first cohort of students in the program began their first semester in Spring 2016, with all subsequent cohorts beginning in a fall semester. The program consists of two separate tracks, one in management and one in logistics information systems, for a total of 10 courses (30)semester hours).

ATHENS STATE BUSINESS STUDENTS TOUR CARPENTER TECHNOLOGIES

As part of Dr. Kim Roberts' Operations Management course, a group of Athens State University College of Business students toured Car-

penter Technology Corporation. The corporation, located in Limestone County, is a leading producer and distributor of premium specialtv allovs, including titanium alloys, powder metals, stainless steels, alloy steels, and tool steels. Students received a guidtour from Perrv Detlor, Director of Operations, which included a rare opportunity to see the world's largest hydraulic radial press.

"I am grateful to the leadership at Carpenter for providing this learning opportunity for our students. Some things are better learned when seen in practice," says Dr. Roberts.



The tour reinforced concepts the students had been learning about such as lean manufacturing, visual management, quality control, and efficiency improvement. Other tour coordinators included Kellie Traynom and Theresa Nelson in Human Resources and Plant Manager, Ernie Jones.

"Not only did the company lead the students on a tour of the facility, but they gave a detailed presentation about direct and indirect costs, flow of inventory, product casting, and other management accounting concepts that the students can better visualize and understand after seeing them first-hand," said Emily Corzine, Assistant Professor of Accounting.
