Faculty Commons Initiative Motion

Given that Athens State University now competes for a dwindling demand for higher education in a global marketplace, the *faculty needs to be a central and creative driver* of the evolution of Athens State from its current state to one that will be attractive to those seeking higher education opportunities in the future. Motion made for the Senate to create ad hoc committee of faculty to combine creativity and analytics to establish recommendations for the university to implement to proactively evolve in the future marketplace, including faculty from all three colleges and the library.

This idea represents a convergence of priorities of student recruitment, responding to business and industry needs, the creation of a faculty commons, and developing a new university strategic plan.
