Proceedings:

Dr. Jameha Gardner, the incoming Presiding Officer (PO), opened the meeting of the university faculty (in-service) at 1:00pm with an introduction of herself and a brief synopsis of her background in education. Dr. Tedi Gordon noted that there were only three senators from the COE and four from the other colleges. She asked if another professor from the COE should be appointed by the dean or if the Presiding Officer, who is COE faculty, was considered the fourth COE representative. Dr. Gardner stated she would follow up on that.

Dr. Gardner stated that, per her conversation with Dr. Wehlburg, there would be an expectation of 10 hours of office hours spread over three days and that all office hours could be virtual for the fall semester.
