

Change of Circumstances Form 2021-2022 Academic Year

Eligibility for financial aid is determined by the Free Application for Federal Student Aid (FAFSA), which currently uses financial information from two years prior to estimate a household's current circumstances. The Office of Student Financial Aid recognizes that households can experience changes in income or other finances that are not reflected in their information from two years prior.

When these situations occur, it is possible to re-evaluate a student's aid eligibility based on their current circumstances through the <u>Professional Judgment (PJ)</u> process. This form can be used to report changes that could affect the 2021-2022 Free Application for Federal Student Aid (FAFSA). Follow the steps below and return this form with the appropriate documentation to the Office of Student Financial Aid. Once the information is reviewed, you will be notified of the decision. All decisions are final. *All documentation is required to be submitted together.* Information will not be accepted after initial submission unless requested by the Office of Student Financial Aid.

Required Documents:

- 1. A detailed letter documenting the facts of your circumstance(s)
- 2. A signed copy of your (and your spouse's if applicable or parent's if dependent) most recent tax return(s) and all appropriate schedules.
- 3. Any documents listed in **Section C** that are applicable after your selection
