 - b. Walkthroughs have been completed to ensure accessibility; Recommendations have been made and enacted to improve accessibility
- V. Workforce Recruitment Program – Juliana Cislo & Saralyn Mitchell
 - a. WRP has shown great success for students with disabilities gaining employment
 - b. 15 students participated in the program for the Fall semester
 - c. Interviews finished this week and employment offers will be known in January
 - d. The Career Development Center assisted students with preparing resumes
 - e. Interviews were completed on campus in a controlled environment and support was in place for these students
- VI. Continuing Topics and Action Updates – Steve Clark, Lisa Philippart, & Kerry Warren
 - a. Docsoft integration is still in process
 - b. Tegrity technology is being replaced by Text Smith Relay and Honorlock; Honorlock should be in place by January if funding is available
 - c. Hearing impaired student video transcriptions are being kept for future use
 - d. Active Minds will be enacted in Spring 2019
 - e. A partnership with Crisis Services has been established
 - f. The behavioral sciences club is no longer active
 - g. Collaboration with the Limestone Advocacy Center is now in place
 - h. Accessibility has been improved throughout the campus; Student accessibility obstacles have been removed
 - i. Student center restrooms have been updated
 - j. Parking issues have been resolved; correct parking sizes and signage have been updated

- k. Automatic doors and restrooms are regularly being checked to ensure student accessibility
- l. Fiddler's accessibility issues are being corrected for the next year
